"The population cannot afford RO and thus we devised a system to harness the vapour particles and collect it as clean water," said Raj Kalavadiya, a team member.

## Postponed DGP meeting now on April 30

AHMEDABAD: The DGP crime conference, which was postponed because of the high alert sounded in the country after the Pulwama terror attack in Jammu and Kashmir, will now be held on April 30 at the Police Bhawan in Gandhinagar.

Police officials above the rank of SP will be attending the meeting where the main agenda will be law and order maintenance and police administration.

"Besides other things, we will discuss ways to relieve pressure on the cops and steps that can be taken to keep our police force fit, physically and mentally," said a senior police officer.

"Giving equal opportunity to women police force and providing them ample field experience is top on the agenda of the meeting," he added.

Issues like allocating weekly offs to police personnel below the rank of inspector and fixing their working hours will also be discussed. "Gujarat being a border state, policing in the state is a crucial issue. Measures to check smuggling of contraband from across the border will also be taken up," added another official.
