Ahmedabad: Narol police have arrested three men in relation to a rape complaint filed by a 20-year-old woman. The victim alleged that one of the accused abducted her and the accused abducted her and coerced her into stealing jewellery and cash from her home. She further accused her lover and his friend of rape, while another friend was accused of abetting the

crime.

The three persons arrested — Chotu Israr, Rinku Gohil, and Milan Thakore — all live in Marol, according to Marol police inspector R M Zala.
Zala explained that Israr met the girl through her mother, who worked at the same factory as him. Israr and the victim developed a relationship and started talking over the phone.
