MEMORANDUM OF ASSOCIATION

OF

GUJARAT NATURAL RESOURCES LIMITED^{*}

- I. The name of the company is **“GUJARAT NATURAL RESOURCES LIMITED”^{*}**.
- II. The Registered office of the company will be situated in the State of Gujarat.
- III. The objects for which the Company is established are as follows:

[A] THE MAIN OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE: [#]

1. To carry on in India or elsewhere either alone or jointly in financial or technical collaboration the business to explore, extract, excavate, procure, produce, pump, refine, purify, store, research, prepare, promote, prospect, process, grade, split, remove, amalgamate, barter, convert, clean, commercialize, compound, distribute, discover, handle, import, export, buy, sell, market, organize, manage, protect, provide, vaporize, condense, concentrate, dilute, mix and to act as agent, broker, stockiest, clearing & forwarding agent, transporter, consultant, engineering contractor, advisor, job worker, export house or otherwise to deal in all sorts of crude, aild refine petroleum oils, natural gases, oleaginous and saponaceous substances substances, their products, by -products, residues, ingredients, derivatives, formulations, blends, mixtures, goods and materials ; and engage in operating, providing, running, chartering of ships, vessels; drilling rigs, machines and equipments and to do offshore drilling, repair and reconditioning of tubulars, to provide oilfield services such as mud logging, cementing, mud engineering, wire lining and to take contracts for prospecting, searching and exploring oil fields, gas fields and other mineral oils and gases and to do all incidental acts and things necessary for the attainment of these objects.^{1.}
2. To carry on the business as manufacturers, formulators, processors, producers, makers, buyers, sellers, re-sellers, importers, exporters, distributors, suppliers, fermentators, distillers, refiners, stockiests, agents, merchants, and dealers in all types, sizes, and kinds of chemical compounds (organic and inorganic) in all forms (solid, liquid, and gaseous), including, but not limited to, polypropylene, polyethylene, and any other polymeric chemical compounds, and of all kinds of organic heavy chemicals, acids, alkalies, tannin extracts, solvents, dye stuffs, dyes, intermediates, bulk drugs and their intermediates, colour chemicals, chemical auxiliaries, biochemicals, and related preparations, articles, and products, whether within or outside India.^{5.}
3. To carry on the business as manufacturers, producers, makers, buyers, sellers, importers, exporters, distributors, agents, brokers, consultants, factors, stockists, commission agents, dealers, market makers of all kinds of iron and steel products.^{2.}
4. To carry on the business as manufacturers, producers, makers, buyers, sellers, importers, exporters, distributors, agents, brokers, consultants, factors, stockists, commission agents, dealers, market makers of all kinds of electronics and information technology products.^{2.}

5. To carry on in India or elsewhere the business of prospecting, exploring, operating and working on mines, quarries and to win, set, crush, smelt, manufacture, process, excavate, dig, break, acquire, develop, exercise, turn to account, survey, produce, prepare, remove, undertake, barter, convert, finish, load, unload, handle, transport, buy sell, import, export, supply, and to act as agent, broker, Adatia, stockiest, distributor, consultant, contractor, manager, operator or otherwise to deal in all sorts of presents and future ores, minerals, deposits, goods, substances & materials, including sands, stones, and soils, chalk, clay, china clay, betonies, broils, calcite and coal, lignite, rockphosphate, brimstone, brine, bauxite, limestone, precious and other stones, gold, silver, diamonds, iron, aluminum, titanium, vanadium, mica, apalite, chrome, copper, gypsum, rutile, sulphate, tin, zinc, zircon, tungsten, silicon, brass, and other allied materials, by products, mixtures, blends, residues & substances, and to do all incidental acts and things necessary for the attainment of the objects under these presents and further to search, survey, discover and find out and to acquire by concession, grant, purchase, barter, lease, license, degrees & tenders the allotment or otherwise of land or water area from government, semi-government, local authorities, private bodies, corporations and other persons, such rights, powers, and privileges whatsoever for obtaining mines, open cast mines, bucket mines, quarries, deposits, etc. for the accomplishment of the above objects in India and outside India.³
6. To carry out the business of managing, supervising, and controlling the business of transmitting, supplying, generating, distributing, and dealing in electricity and all forms of energy and power generated by any source whether steam, hydro or tidal, water, wind, solar, hydrocarbon fuel, or any other form, kind, or description. This includes setting up and operating solar, wind, and hybrid energy parks, along with the generation and distribution of energy through Photo Voltaic (PV) modules (panels), solar inverters, charge controllers, mounting structures, wires, PV solar heaters, batteries, solar lanterns, solar chargeable lights, fans, wind mill nacelle, generator, wind mill towers, wind mill blades, batteries etc.⁴
7. To carry out the business of manufacturing, trading, importing, exporting, installing, and operating solar systems for energy generation, including Solar Photovoltaic, Solar Thermal, Solar Chimney, and other solar-based devices used in households, industries, and commercial establishments and wind energy through wind mill nacelle, generator, wind mill towers, wind mill blades, batteries etc. This includes the setting up of greenfield solar, wind, and hybrid energy plants of various sizes, identifying and acquiring suitable land (either on lease or by ownership), developing sites for solar, wind, and hybrid parks, and designing, engineering, supplying, erecting, commissioning, and operating and maintaining these plants. The company shall also provide renewable energy solutions and may sell or dispose of part or whole of the solar, wind, and hybrid energy plants, both in India and abroad.⁴

[B] Matters which are necessary for furtherance of the objects specified in Clause III [A] are

1. To erect forging plants, rolling mills, roughing for the purpose of rolling stainless steel, iron steel and other metals.
2. To undertake and execute any contracts for works involving the supply or use of any machinery, and to carry out any ancillary or other works comprised in such contracts.
3. To introduce, buy or sell in the Union of India or elsewhere in the world as importer, exporters, merchants, manufacturers, agents, or otherwise, any metals, metal-powders, minerals, mineral substance, chemicals, goods and materials, articles, or appliances and generally to purchase, sell deal in and supply as manufacturers, distributor-s, merchants, agents all kinds of metals, metal powders, minerals, mineral substance, chemicals, goods, products, appliances or things which can be objects which the company from the time to time may deem fit or expedient to carry on in connection with its main business at any time being conducted and which may seem calculated or capable of being conducted so as to directly or indirectly benefit the company.
4. To build, construct maintain, enlarge, pull own, remove or replace, improve or develop and to work, manage and control any buildings, offices, factories, mills, foundries, refineries, furnaces, godowns, warehouses, shops, machinery, engines, roadways, railways or other means of transport, sidings, bridges, reservoirs, dams, water courses, water systems, wharves, electric works, gas works, or works operated by any other kind of power and also such other machinery's equipment, conveyances, works which may seem calculated directly or indirectly to advance the interest of the Company and to subsidise; contribute to or otherwise assist or take part in doing of those things and or to join with any other person or company or with any Government or Governmental authority in doing any of these things.
5. To apply for, purchase, or otherwise acquire, and protect and in any part of the world any patents, patents rights, brevets d'invention, trade marks, designs, licences, concessions, and the like, conferring any exclusive or non-exclusive or limited right to their use or any secret or other information as to any invention which may seem capable of being used for any of the purposes of the company, or the acquisition of which may seem calculated directly Or indirectly to benefit the company, and to use exercise, develop, or grant licences in respect of, or otherwise turn to account the property, rights or information so acquired and to expend money in experimenting upon testing or improving any such patents, inventions Or rights, and without prejudice to the generality of the above any contracts, monopolies or concessions for or in relation to the supply and sale of any minerals, metals, products or other substances, materials articles or things or for in relation to the construction, execution carrying out, equipment, improvement, management, administration, or control of any works and conveniences required for the purpose of carrying out any of the aforesaid business and to undertake execute, carry out, dispose of for otherwise turn to account such contracts; monopolies or concessions.
6. To acquire from any Government, Central or State, Local or Foreign, or public body or persons or authority, or from any private individual any concession, grant decrees, rights, powers and privileges whatsoever which may seem to the Company directly or indirectly conducive to any of its business, and to work develop, carry out, exercise and turn to account the same.

7. To apply for, promote and obtain any Act of Parliament, charter, privilege, concession, licence or authorisation of any Government, State or Municipality, provisional order or licences from any authority, for enabling the Company to carry out any of its objects into effect or for extending any of the powers of the company or for effecting any modification or the constitution of the company or for any other purpose which may seem expedient and to oppose any proceedings or applications, which may seem expedient and to oppose any proceedings or applications, which may seem calculated directly or indirectly to prejudice the interest of the company.
8. To experiment and to incur expenses necessary for the purpose with a view to improve on the present method and process of working the several business which the company is authorised to carry on and to carry on research for improving, developing or effecting economy and greater efficiency in the processes for the production, manufacture and working of or training or dealing in various substances, materials and articles and things or with any of the business for which the company is established.
9. To purchase, take on lease or licence or in exchange hire or otherwise any real and/or personal property and any rights or privileges which the company may think necessary or convenient for the purposes of its business or may enhance the value of any other property of the company and in particular any land (free-hold or other tenure), buildings, easements, machinery, plant, stock-in trade, and on any such lands to erect buildings, factories, sheds, godowns, or other structures for the works and purposes of the company and also or residence and amenity of its employees, staff and other workmen and erect and install machinery and plant and other equipments deemed necessary or convenient or profitable for the purpose of the company.
10. To exchange, sell, convey, assign or let on lease or grant licence for the whole or any part of the company's immovable properties and to accept as consideration or in lieu thereof other land or cash or government securities, or securities guaranteed by government or shares in Joint Stock Companies or partly the one and partly the other or such other property or securities as may be determined by the company and to take back or require any property so disposed of by repurchasing or leasing the same or obtaining a licence for such price or prices and on such terms and conditions as may be agreed upon.
11. To enter into any agreements with the government of India or any other government or with any authorities, public, municipal, local, railway, or otherwise or with any other person, that may seem conducive to the objects of the company or any of them, and to obtain from any such government, authority or persons any rights, privileges, charities, contracts, licences and concessions which the company may think it desirable to obtain, and to carry out exercise and comply therewith and dispose of or turn to account the same.
12. To amalgamate, enter into partnership or into any arrangement for sharing profits union of interest, co-operation, joint venture or reciprocal concession, or for limiting competition with any person or company carrying on or engaged in, or about to carry on or engage in, any business or transaction which the company is authorised to carry on or engage in, or which can be carried on in conjunction therewith or which is capable of being conducted so as directly or indirectly to benefit the company.

13. To purchase or otherwise acquire and undertake the whole or any part of the business, property, rights and liabilities of any persons, firm or company, carrying on or proposing to carry on any business which this company is authorised to carry on, or possessed of property or rights suitable for any of the purposes of the Company or which can be carry on in conjunction therewith or which is capable of being conducted so as directly or indirectly to benefit the company.
14. To purchase, acquire, sell and deal in property, shares, stocks, debenture-stock of any such person, firm or company, and to conduct, make or to carry into effect any arrangements in regard to the winding up of the business of any such person, firm or company.
15. To improve, manage, develop, grant rights or privileges in respect of, or otherwise deal with all or any part of the property and rights of the company.
16. To promote and form and to be interested in and take, hold and dispose off shares in other companies to transfer to any such company any property of this company and to take or otherwise acquire, hold and dispose of shares, debentures, and other securities in or of any such company and to subsidise or otherwise assist any such company.
17. To sell, lease, mortgage or otherwise dispose or transfer the business property, assets or undertaking of the company or any part thereof for such consideration as the company may think fit and in particular for shares, stocks, debentures or other securities of any other company whether or not having objects altogether or in part similar to those of the company.
18. To pay for any rights or property acquired by the company, and to remunerate any person or company whether by cash payment or by allotment of shares, debentures or other securities of the company credited as paid-up in full or in part or otherwise.
19. To payout of the funds of the company all costs, charges and expenses which the company may lawfully pay with respect to the promotion, formation and registration of the company and which the company shall consider to be preliminary, and expenses attendant upon the formation or agencies, branches and local boards.
20. To borrow or raise money, or to receive money, on deposits or loan at interest or otherwise in such manner as the company may think fit and in particular by the issue of debentures or debenture-stock perpetual or otherwise and convertible into shares of this or any other company or not and to secure the repayment of any such money borrowed, raised or received or owing by mortgage, pledge, charge or lien upon the all or part to the property, assets or revenue of the company (both present and future) including uncalled capital and to give the lenders or creditors the power of sale and other powers as may seem expedient and to purchase, redeem or payoff any such securities and also by similar mortgage, charge, or lien to secure and guarantee the performance by the company or any other person, firm or company of any obligation undertaken by the company or any other person, firm or company as the case may be.
21. To receive money on deposit subject to the provisions of Companies Act and Company's Deposit Rules with and without allowance of interest thereupon and to guarantee the debts and the contracts of customers and other provided that the company shall not carry on business of Banking as defined by the Banking Regulation Act, 1949.
22. To advance and lend money upon such security as may be thought proper or without taking any security thereof.

23. To subsidise, assist and guarantee the payment of money by, or by the performance of any contract, engagement or obligation by any persons or companies, with whom the company may have or intend to have business relations.
24. To procure the incorporation registration or other recognition of the company in the country, state or place and to establish and regulate agencies for the purpose of the company's business and to apply or join in applying to any Parliament. Government, Local, Municipal or other authority or body or any Acts of Parliament, Law, decree, concessions, orders, rights, or privilege that may seem conducive to the Company's objects or any of them and to oppose any proceedings or applications which may be calculated directly to prejudice the Company's interests.
25. To open and keep a registers in any country or countries where it may be deemed advisable, to do so and to allocate any number of shares in the company to such register or registers.
26. To establish and maintain or purchase the establishment and maintenance of any contributory or non-contributory pension or superannuation funds for the benefit of, and give or procure the donations, gratuities, pensions, allowances or emoluments to any persons who are or were at any time in the employment or service of the Company, or of any company, which is subsidiary of the company Or is allied to or associate with the company, or who are/were at any time the Directors, Officers of the company, or of such other company as aforesaid and the wives, widows, families and dependent or any such persons, and also establish and subsidise and subscribe to any institutions, associations, clubs or funds calculated to the benefit of or to advance the interests and wellbeing of the company or of any such other company as aforesaid and make payments to or toward the insurance of any such person as aforesaid and to any or the matters aforesaid either alone or in conjunction with any such person as aforesaid and to any of the matters aforesaid either alone or in conjunction with any such other company as aforesaid.
27. To subscribe or contribute or otherwise to assist or to guarantee money to charitable, benevolent, religious, scientific, national, public or any other useful institution, object or purpose, or for any exhibition.
28. To distribute in specie or otherwise as may be resolved any property or assets of the company or any proceeds of sale or disposal of any property or assets of the company including the shares, debentures or the securities of any other company formed to make over the whole or any part of the assets or liabilities of the company but so that no distribution amounting to a reduction of capital be made except with the sanction (if any) for the time being required by law.
29. To give to any Officers, Servants or Employees of the company any share or interest in the profits of the company's business or any branch thereof, and whether carried on by means or through the agency of any subsidiary company or not and for that purpose to enter into any arrangement the company may think fit.
30. To invest in any real or personal property, rights or interest acquired by or belonging to the company in person or company on behalf of or for the benefit of the company and with or without any declared trust in favour of the company.
31. To act as agents or brokers and as trustees for any person or company and to undertake and perform sub-contracts and to do all or any of the above things in any part of the world and as principles, agents, contractors, trustees and by or through agents, sub-contractors or trustees or otherwise and either alone or jointly with others.

32. To train or pay for the training in India or abroad of any of the company's employee or any candidate in the interest of or for furtherance of the company's objects.
33. To carry on any business or branch of a business which this company is authorised to carry on by means or through the agency of any subsidiary company or companies and to enter into any arrangement with any subsidiary company or taking the profit and bearing the losses of any business or branch so carried on, or for financing any such subsidiary company or guaranteeing its liabilities, or to make any other arrangements, which may seem desirable with reference to any business or branch so carried on, including power at any time either temporary or permanently to close any such business or branch and to appoint Directors or Managers of any such subsidiary company.
34. To the extent directly or indirectly conducive to or incidental to the attainment of the above objects or make and perform contracts, leases and other commitments of every kind.
35. Generally to acquire by purchase, lease or otherwise for the purposes of the company any real or personal property, rights or privileges, and in particular any land, buildings, rights of way, easements, licences, concessions and privileges, patents, rights, machinery, rolling stock, plant, accessories and stock-in-trade.
36. To establish and maintain any agencies in any part of the world for the sale of any materials or things for the time being at the disposal of the company for sale.
37. To invest and deal with the moneys of the company, not immediately required in such manner as may from time to time seem expedient and be determined.
38. To draw, accept, make, endorse, execute and issue bills of exchange, promissory notes, debentures, bills of lading and other negotiable or transferable instruments or securities, and to lend money to such persons and on such terms as may seem expedient and to give any guarantee or indemnity that may seem directly conducive to any of these objects.
39. To provide for the welfare of Directors or employees or ex-employees of the company or its predecessors in business and the wives, widows and families or the dependents or connections of such persons by binding or contributing to the building of houses or dwellings or quarters or by grant of money, pensions, gratuities, allowances, bonuses, profit sharing and from time to time subscribing or contributing to provident and other associations, institutions, funds, profit sharing or other schemes or trusts and by providing or subscribing or contributing towards places of instruction and other assistance as the company shall think fit.

To capitalise such portion of the profits of the company as are not distributed among shareholders of the company in the form of dividend as the Directors of the company may think fit subject to the consent of the shareholders in general meeting and with the sanction of the general meeting of the shareholders to issue bonus shares as fully paid up in favour of the shareholders.
