12 November is observed as World Pneumonia Day to bring people from all over the world together uniting to demand that something be done to fight the pneumonia illness. The Day is observed annually to raise awareness about pneumonia, a leading cause of death worldwide. This year's theme, "Every Breath Counts: Stop Pneumonia in Its Tracks," emphasizes the importance of collective action to prevent and treat pneumonia. Pneumonia is caused by a number of infectious agents including viruses, bacteria and fungi. Pneumonia is one of the most solvable problems in global health and yet a child dies from the infection every 20 seconds. Pneumonia is a major public health concern, particularly in low- and middle-income countries.

million lives annually, including 700,000 children under five. It's the leading infectious killer of children under five, accounting for 15% of all deaths in this age group. This devastating toll demands collective action to prevent, treat, and protect vulnerable populations. Sub-Saharan Africa and South Asia are the most affected regions. It can be caused by bacteria viruses or fungi. WHO, UNICEF, and the "Every Breath Counts" coalition lead initiatives to reduce pneumonia-related deaths. Governments and organizations promote awareness, vaccination, and healthcare access. India's Intensified Mission Indradhanush and Ujjwala Yojana aim to improve immunization and clean cooking fuels. India accounts for nearly one-fifth of global pneumonia deaths among children under five. Malnutrition, indoor air pollution, and poor healthcare access exacerbate the issue.

Now it is time to increase the political and societal will, motivation and action to reduce pneumonia and diarrhea. National access to Hib and PCV vaccines is a crucial component in the battle to prevent illness and death from childhood pneumonia. An investment to protect every child from pneumonia is an investment in India's future and social justice. Controlling childhood pneumonia required correct and consistent delivery of an integrated package of

interventions to protect, prevent, and treat the disease. Prevention is essential to interrupt the vicious cycle of ill health and poverty. Vaccines not only keep children from getting sick but protect the community by reducing the circulation of disease. Effective measures can prevent pneumonia like Pneumococcal conjugate vaccine (PCV), Hib vaccine, influenza, and measles vaccines. Good nutrition and exclusive breastfeeding. Hygiene practices viz. handwashing, mask-wowing. Timely antibiotics and oxygen therapy can treat pneumonia. The World Health Organisation's new guidelines on indoor air quality set targets for reducing harmful household pollutants and offer greater clarity on specific fuels considered unsafe for use in the home. WHO has urged the world community to step up efforts to reduce children's exposure to toxic smoke from indoor cooking fumes and increase the proportion of babies fed with breast milk, especially in the critical months after birth. We need to strengthen efforts to bring down decrease infant child mortality due to pneumonia. Clean environment, addressing malnutrition, encouraging breast feeding, timely immunization will reduce mortality rate. # Gambling, torture and finally suicide

## The mystery of the suicide of a builder's son from Gandhinagar is shrouded in suspicion of dealing in lakhs with an acquaintance of his father-in-law

Gandhinagar  
On January 28, the body of a 25-year-old youth was found in the Narmada Canal. The body belonged to Rishabh Patel, the son of a builder living in Shikhar Bungalows at Sughad in Gandhinagar. Rishabh Patel had committed suicide by jumping into the Narmada Canal just 13 days after his marriage.

In the suicide case of the builder's son in Gandhinagar, speculation and torture have now been revealed. Apart from this, the transactions worth lakhs with the father-in-law's acquaintances have also come under suspicion. Now, the mystery of the builder's son's suicide is getting deeper due to all these aspects.

It is worth mentioning that the father had filed a complaint against four persons, including the son of a former corporator, at the Infocity police station in connection with his son's death. The police have arrested one accused and have obtained remand from the court till February 2 and are conducting a thorough investigation.

The accused are acquaintances of the deceased Rishabh's father-in-law.

In the suicide case of 25-year-old Rishabh Patel, associated with the Gandhinagar construction business, a complaint has been registered at Infocity Police Station by the deceased's father Pravinbhai for abetting the suicide of four persons. The police investigation has also revealed that the accused are acquaintances of the deceased Rishabh's father-in-law.

Rishabh, who had been mentally and physically harassing the son of an accused former corporator for two to three months in a money laundering case, took the final step. One of the four accused, Manish alias

Splendor, has been revealed to be the son of former corporator Taraben Patel. Currently, the police have arrested one accused named Mahipal Singh and have intensified efforts to nab the remaining accused.

Police arrested Mahipal Singh Rathod and registered a case in this regard. As soon as the PI of Infocity Police Station V.R. Kher and his team started an intensive investigation and arrested Mahipal Singh Rathod, the manager of Tabun Pan Parlour. Police produced the accused in court and obtained remand till February 2. In the preliminary interrogation of Mahipal Singh, Krishal Patel and Rishabh are both friends.

Krishal wanted to take 4 lakhs from Rishabh while Manish alias Splendor and Kalpesh alias Talati are friends of Krishal. Since all four knew each other, they used to go to the parlour to sit. Krishal wanted to take 3.5 to 4 lakhs from Rishabh. Similarly, Manish and Kalpesh were also demanding money from Rishabh. Due to which Rishabh was beaten up at another parlour near Nana Chlodha.

The entire matter is suspected to be related to the transaction of money from betting.

On the other hand, the suicide note also does not mention the specific reason for the mental torture and the family members also claim that they do not know anything, claiming that these four people are running a gang from 007. Following which the police have taken Mahipal Singh along to the crime scene and taken the investigation further. So the police suspect that the entire incident was related to the transaction of money from betting.

# Karva Chauth photo with vermilion in demand caused bloodshed

## Lover sent photo to ex-husband and a murder plan was hatched, tragic outcome of strained relationship in Vadodara

On January 27, 2026, Vishal Kahar stabbed his live-in partner's ex-husband Mohammad Hussain Zulfiqar Ali Syed in the head and neck and disemboweled him in front of the old Panigate police station in Vadodara. After this attack, chaos prevailed in Panigate. Currently, the accused's remand has been completed and the accused has been sent to jail.

Vishal Kahar had stabbed his live-in partner's ex-husband Mohammad Hussain Zulfiqar Ali Syed in the upper and lower parts of his body and disemboweled him. People rescued Mohammad Hussain Zulfiqar and shifted him to Sayaji Hospital via 108.

The murder of a young man in Vadodara is the work of a woman who had previously divorced her husband and had an affair with another Hindu married man. This woman was in contact with the accused Vishal Kahar for the last six years. Who and what was the objection to the love relationship between Vishal and this woman and why was the lover finally forced to kill her ex-husband?

They came into contact while riding in a rickshaw and fell in love.

The accused Vishal Kahar was a rickshaw driver and came into contact with this woman six years ago. Later, when he was taking her in a rickshaw, the woman told him that she was applying mehendi, and Vishal took her phone number and took her into his confidence to get her the job. After that, the two started talking frequently. Later, this relationship turned into love.

The twist came when Pramika Mitra's ex-wife came out,

but both of them did not know that there were many obstacles to this love relationship and that its outcome would be bloody. In this, the relationship got another twist when it was revealed that this woman's ex-husband was Vishal's friend. Vishal's girlfriend and her ex-husband got divorced two years ago. While Vishal was also married.

In this love story, his girlfriend is divorced, he is married, and his girlfriend's ex-husband is his friend again. There was no doubt that the shades of this combination of relationships were dark.

Despite this love affair, the friendship between the deceased Mohammad Hussain Zulfiqar Ali Syed and Vishal was unbreakable. Vishal's live-in partner lived separately with the children born to her ex-husband. While Vishal has a wife and two children.

The house started to crumble when the wife found out.

One day, the wife came to know about Vishal's affair with this woman. Due to which frequent fights started happening between the two. Not only that, the family members of the deceased youth also went to the accused Vishal's house and had a fight over this matter.

Forced lover to convert to religion, attempted suicide

According to information received from police sources, the wife of the deceased youth was forcing accused Vishal to convert to religion and marry after the divorce. Apart from this, his lover once tried to commit suicide after going to Vishal's house.

Pressured girlfriend to change religion:

Accused Vishal Kahar's wife writes a letter to the

Vadodara Police Commissioner regarding this matter. In which, the woman's affair with her husband and the fact that she was repeatedly blackmailing her husband Vishal by threatening him with death and pressuring him to change religion. Along with this, Vishal was also pressuring this woman to give up her religion and adopt Hinduism.

Vishal's girlfriend, despite being of a different religion, takes a photo with the accused Vishal, smeared with vermilion, while observing the fast of Karva Chauth. Vishal sends this photo to his friend and girlfriend's ex-husband. This same photo plants the seeds of this murderous game.

'Why are you sending me photos even though I am divorced?'

The deceased Mohammad Hussain Zulfiqar Ali Syed along with his family members went to the house of accused Vishal and asked him why he was sending me photos even though I am divorced. Later, a fight broke out between Vishal and the deceased youth over this issue.

A plan was hatched to kill the ex-husband and friend of the girlfriend.

On the night of January 27, Vishal and the deceased youth meet in the Panigate area. The house of the accused and the deceased youth is only 100 meters away from this place. However, even before this meeting, Vishal has hatched a plan to kill Mohammad Hussain Zulfiqar Ali Syed and as part of his preparations, he brings a knife from home.

Before the intestines were removed and the person was killed, there was a general fight over this matter and later this fight resulted in murder.

# Principal allocates 2 bighas to keep children away from mobile phones

Mehsana, In today's digital age, when children's childhood is being captured on mobile screens, a wave of

Here, children are trained in running, volleyball, kho-kho, long jump, cycling and yoga.

## Couple on two-wheeler in Ahmedabad become victims; Luxury bus rams into truck on highway in Vadodara

A hit and run incident has come to light on the Balohnagar Bridge in Ahmedabad late last night (January 30). While the husband and wife were going on an Activa, a car driver from behind hit the Activa at high speed, causing the young man driving the Activa to fall off the bridge, in which the Activa driver named Kishan Vacheta died, while his wife Komal was injured. It is worth mentioning that the CCTV installed on the bridge is also switched off. The deceased's friend

expressed his anger over this and said that if leaves or netting had been placed on the bridge, my friend's life would have been saved. My friend's life has been lost due to the negligence of the corporation.

National Highway 48 passing through Vadodara has become a highway of death, with one horrific accident after another. After the Karjan-Dhavat Bridge yesterday, another accident has occurred near Bamangam Patiya today (January 31), in which a private luxury bus collided with a truck moving in front. The driver died on the spot and more than 20 people suffered minor injuries, while more than two people are reported to be in serious condition. For the second consecutive day, three people have died in two days due to accidents. A 28-year-old man named Kishan Vacheta, who lives in a housing scheme house in Janata Nagar, was going from Balohnagar to Chandkheda via New Ranip with his wife Komal. The driver died in this incident, my family members were in the front sofa, they were also injured and are undergoing treatment. We had gone for my own marriage.
