

IRF FOR INSTALLATION OF MANDATORY FRONT AND REAR FOG LIGHTS

Ahmedabad, International Road Federation (IRF), Geneva based global body working for better and safer roads worldwide expressing deep concern at increasing fatal road crashes and vehicle pile ups due to fog, has urged the Government to make front and rear fog lights mandatory on all vehicles. "The Worldwide research has shown that increased visibility between vehicles reduces crash risk by more than 30 per cent, especially during fog months of December to February and in the fog prone areas. Foggy conditions pose a threat to motorists, and a law to make both front and rear fog lights mandatory, could help reduce the risk of road crashes caused by poor visibility. Fog lights are extremely useful during

conditions of poor visibility caused by rain, fog, dust or snow" said Mr K K Kapila, President Emeritus , International Road Federation (IRF). "Fog lights and automated vehicle lights that switch on due to poor natural light or fog, or during low-visibility conditions, could reduce the risk of collisions. In Europe, the vehicles are fitted with front and rear fog lights as a standard feature for better visibility in fog like conditions. However, installing fog lights will not on its own eliminate the risk of crashes during foggy conditions, various other countermeasures are also needed for providing safer driving environment, by both the Government, drivers as well as the Civic Agencies " said Mr. Kapila. Scoliosis Awareness Seminar Held in Ahmedabad



Ahmedabad, To increase awareness about scoliosis and the importance of early diagnosis, a special awareness seminar on scoliosis was organized in Ahmedabad, bringing together some of India's and the world's leading spine surgeons on a single platform. The seminar aimed to educate parents, patients, caregivers, and the general public about scoliosis—a spinal deformity that often remains undetected until it significantly progresses. The expert panel included Dr. Amit Jhala (Ahmedabad), Dr. Ajay Prasad Shetty T (Chennai), Dr. K. Venugopal Menon (Kochi), Dr. Shaishav Bhagatara (London), Dr. Sharvin Sheth (Ahmedabad), and Dr. Hriday Acharya (Ahmedabad). The surgeons collectively

highlighted the need for early detection, timely intervention, and access to modern treatment options to improve long-term outcomes. According to global and Indian studies, scoliosis affects nearly 2–3% of children and adolescents, translating to over 2 crore individuals in India. Medical experts note that in India, nearly 60–70% of scoliosis cases are diagnosed at a late stage, primarily due to lack of awareness and absence of routine screening. In Gujarat, hospital-based data indicate that 2–3 out of every 100 school-going children show signs of spinal curvature, with urban centres like Ahmedabad, Surat, Vadodara, and Rajkot witnessing a steady rise in cases over the past decade. What Putin's Delhi visit and India-Russia 2.0 mean for China

The India-Russia relationship has overwhelmingly been defined in terms of one pillar: defence. India's military modernisation, from aircraft and submarines to spare parts, has clear Russian footprints. However, the Russian President Vladimir Putin's visit to Delhi this month signalled a structural shift in this relation. As External Affairs Minister S Jaishankar noted, the India-Russia partnership, which is "one of the steadiest big relationships in the world", has now been "reimagined" to strengthen areas that have historically "lagged, particularly economic cooperation".

The consequences of this transition from defence dependence to broader economic interdependence go much beyond the bilateral realm. The India-Russia ties underscore the evolving Asian power landscape and, in particular, compel regional and global powers like China to reassess the emerging strategic environment near their periphery. This pivot is shaped by wider regional and global contexts. The long-term policy trajectory has been clear and well defined: enhancing its strategic autonomy by diversifying the supply chains, broadening economic partnerships, and minimising fragility due to one-source reliance.



While historically being heavily inclined towards Russia, India had to consider the contemporary dominant geopolitical model that is defined in terms of technological innovations, energy insecurity, and contested access to critical minerals. India's own economic ambitions that depend on industrial modernisation and electric-

mobility transitions require deeper, more varied and more resilient partnerships. Similarly, Russia's intention to seek more balanced global economic linkages is due to Western sanctions and over-dependence on China. These converging motivations have set the grounds for a renewed, reinvigorated and multi-sectoral partnership for both India and Russia. The Delhi Summit's New Playbook

The set of agreements endorsed by the two governments in the recent summit meeting set the tone for this tactical shift, covering mutual cooperation on nuclear energy, mechanisms for critical-minerals trade, enhanced relations in shipbuilding, new frameworks for labour mobility, and strengthened coordination on fertilisers and agricultural goods. Prime Minister Narendra Modi described the new "Economic Cooperation Programme till 2030" as central for diversifying the country's trade and investment linkages. India not only looks to buy more from Russia but also intends to build sustained long-term industrial, logistical, and regulatory mechanisms to mitigate swings in its core economic sectors.

The message from President Vladimir Putin was just as unmistakable. He reiterated that Moscow remains a "reliable supplier" and pledged "uninterrupted" fuel shipments to India. He further emphasised Moscow's intentions to broaden cooperation beyond hydrocarbons, extending into pharmaceuticals, nuclear technologies, joint manufacturing ventures, and

IND vs SA at NaMo Stadium today

Ahmedabad, The final and decisive match of the five-match T20 series between India and South Africa will be played today at the Narendra Modi Stadium in Ahmedabad. Both the teams reached Ahmedabad yesterday evening. Team India stayed at ITC Narmada Hotel while the South African team stayed at Hyatt Regency. Ahmedabad Police has also made security and traffic arrangements keeping in mind the match, while metro services have also been extended till 12:30 am. Notification regarding vehicles during the match: As a large number of people are expected to move during the T-20 match to be held at the Narendra Modi Stadium today, the Police Commissioner has issued a notification regarding vehicle movement. In which, the road from Janpath T to Motera Stadium Main Gate, via Krupa Residency T to Motera Village T will be restricted for vehicle movement. Metro will run till late night in view of the match to be held today. Keeping in mind the fifth T20 match to be held at the Narendra Modi Stadium today, the Metro timings have been extended till 12.30 am. The current timings of metro train services in Ahmedabad are from 6:20 am to 10 pm. During the extended hours from 10 pm to 12:30 am, one can board the metro only from Motera Stadium Metro Station and Sabarmati Metro Station and from there go to any operational metro station of both the corridors of Ahmedabad Metro (Motera to APMC and Thaltej Gam to Vastram Gam). To reach Gandhinagar, two additional metro trains will depart from Motera Stadium to Sector-1 at night at 11.40 am and 12.10 am. Special paper tickets have been issued for night return from the stadium. In addition, GMRC has issued special paper tickets for night return from Motera Stadium only on the day of the T-20 match to avoid any inconvenience to the metro passengers.
